#### **A Cybersecurity Powerhouse**



In 2024, B.C. secured \$2.5 billion in cumulative venture capital (VC) funding, reflecting strong investor confidence and the province's rising status in tech. The Canadian government is investing in the cybersecurity industry, including \$80 million to support the creation of a national cybersecurity network of industry-academia collaboration. With six of the top ten global software companies establishing a presence here, such as Microsoft, Amazon/AWS and IBM, British Columbia offers a dynamic talent pool and a growing culture of innovation.
